Robert "Bob" Knox, 89, of Big Canoe passed away December 19, 2020. Bob founded Knox Jewelers, Inc. in Sandy Springs and remained active in the business until 2020. He served as president of GJA decades ago and was followed later by his son and business partner Eddie Knox who was GJA's president a decade ago. Bob and his wife of over 65 years, Fran, had been residing in Big Canoe in North Georgia the last couple of years.

Bob is survived by his wife Fran, his son Eddie and wife Natasha Knox, Cumming, four grandchildren and four great grandchildren. He was preceded by a son, Alan Gregory "Greg" Knox. The family held private services. While it has been many years since Bob has participated in GJA, I know there are many members who have industry memories with Bob and remember him fondly.





John Harvey Cantrell, Bremen, GA, died peacefully with the love of his life Janice Nichols by his side. Johnny passed away January 28, 2021 at the age pf 95. Navy veteran, Battle for Iwo Jima survivor, clock repairman, gemologist, skilled jeweler, and successful store owner, Johnny led an eventful 95 years.

Loved by his hometown of Bremen, Johnny knew everyone, and everyone knew him. For years he was delighted to serve as the Grand Marshall of the Memorial Day parade. We have all seen the image of the Marines raising the American flag at Iwo Jima and Johnny watched it live. He was awarded ribbons with gold stars for Iwo Jima, Okinawa, Saipan, the Marshall Islands, and the Philippines. His stories were endless and interesting, though often hard to tell.

Johnny arrived back in Bremen in 1945 and joined his brother Horace in the jewelry business. Cantrell Jewelers anchored downtown Bremen until Johnny's retirement at age 88. A small private service was held.

William "Bill" Rosenfeld. Bill was GJA president from 2014 – 2016 and served on the board for many years rising up through the ranks and then serving on the past presidents committee to help advise the incoming board members. Bill always had a smile for everyone when he walked in the room and usually had his beautiful wife Carmen, on his arm at every GJA convention.

Besides running Rosenfeld Jewelry LTD in Tucker, Bill was a giant in the Tucker business community and served as a councilman on the Tucker city council. He had lots of friends in his Rotary and just as many that he enjoyed playing golf with. Recently, we've all enjoyed watching Bill's barbequing expertise grow on social media. Bill had a past life as a paramedic and served with the Dekalb County Fire and Rescue before those of us in the jewelry industry had the pleasure of working with Bill and getting to know him.

Bill is survived by wife, Carmen Rosenfeld, sister Penny Kimrey (Donald), brother Jimmy Suggs (Jackie); children Corey Rosenfeld (Sally) and Christy Rosenfeld-Lyvers and six grandchildren. GJA and many in the Atlanta area will miss him and mourn him with Carmen and his family and his staff.

Protect Your Jewelry Business from Cybercrime

Many small businesses are turning to e-commerce as an additional way to reach their customer base and make sales. These digital e-commerce platforms provide convenience for the consumer.

As e-commerce technology continues to evolve and become more sophisticated, criminals are developing tactics to target your assets without ever stepping foot inside your business.

Common Types of Cybercrime:

- Identity theft using phishing techniques via email, text or phone call.
- Setting up fake accounts that mimic those of a company's suppliers, and then asking for payment to that account.
- Taking over a store's mailing system to obtain private information from its customers.


The best way for you to protect your business and customers is to be aware of your vulnerabilities and implement steps to strengthen your security.

Even if you do not sell inventory online, any computer connected to the internet can become a target, a source of attempted crime. This is even more relevant if you have a broadband connection using either a cable or DSL connection that is always on.

Other Security Tips Include:

- •Add security and anti-virus/anti-malware software to any computer connected to the internet. Depending on how you use the internet, increase the levels of intrusion protection and detection including firewalls making certain to change the product default passwords.
- •Keep your systems current with applicable vendor security patches and update anti-virus/anti-malware software weekly or even daily.
- Take extreme caution when opening and downloading email attachments unless you know exactly what it is and that it's from a reliable source.
- Take extreme caution when clicking on links in emails unless you know it is from a reliable source. Email phishing is the most common way computers are compromised.
- •Protect access to inventory records or financial records stored on computers to prevent disgruntled or former employees from stealing, altering or destroying important business data. Protect data that is stored restrict access, use security software to encrypt data, and do not retain data for longer than necessary. Protect both the primary source and any backups.
- •Use access protection methods, such as strong passwords or passphrases, to prevent access to unauthorized persons. Multi-factor authentication is recommended when connecting to systems remotely.
- •Back up and save computer data regularly. Test the back-ups often and store the back-ups at a site away from your business location. Encrypting backups is recommended.

For added security, you can also protect your business with a cyber liability insurance policy. This covers the loss of money incurred due to financial fraud, as well as liability claims where there is a duty to defend lawsuits or regulatory penalties are incurred.
